

## Orlando Vacation Getaway Official Rules

### **1. INTRODUCTION**

Orlando / Orange County Convention and Visitors Bureau, Inc. ("OCVB") is offering the Orlando Vacation Getaway ("Sweepstakes"). **NO PURCHASE OR OBLIGATION IS NECESSARY.** By entering this Sweepstakes, entrants agree to abide by all terms of these Official Sweepstakes Rules and the decisions of Dial Global ("Sweepstakes Administrator") and Sponsors, whose decisions shall be final and binding. **VOID WHERE PROHIBITED.**

### **2. ELIGIBILITY**

This Sweepstakes is open only to individuals who are **21 years of age or older** and legal residents of the United States at the time of entry. Individuals who have already won a prize twice from Sweepstakes Administrator in the month of November 2009 are NOT eligible to qualify/win. ### **3. HOW TO ENTER**

Sweepstakes begins at 12:00 a.m. EST on November 2, 2009 and ends at 05:00 p.m. EST on November 24, 2009 ("Sweepstakes Period"). Participants will be required to listen for the word of the day and may then enter online at [www.musicandprizes.com](http://www.musicandprizes.com). Participants may also be invited to call-in to the 800 phone number announced during broadcasts of the "AC" program (the "Program") during the Sweepstakes Period. No responsibility is assumed by Sweepstakes Entities for any telephone or other technical malfunctions that may occur.

Each AC affiliate that chooses to collect entries at local live remote broadcasts may submit five entries per remote (no more than two remotes per week) during the duration of the promotion. Local radio station affiliates are responsible for awarding runner-up prizes, if any, to its own grand prize entrants for this Sweepstakes. Local qualifier names (Make sure to include: Name, Address, Birthday, Phone Numbers) must be submitted to the sweepstakes administrator no later than November 23, 2009 at 5 PM EST.

### **4. WINNER SELECTION**

All entries (From the network and affiliates) will be put in the grand prize drawing and selected on November 24, 2009.

The grand prize winner will be announced on the air on: November 25, 2009. .

One entry per household.

The grand prize drawing will be conducted by an impartial representative of Sweepstakes Administrator.

### **5. PRIZES**

GRAND PRIZE: One grand prize trip will be awarded. Trip includes round-trip coach air transportation, provided by AirTran Airways, from a major airport nearest the winner's residence for 4 people (the winner and up to three additional individuals designated in writing by winner) who must travel together to Orlando.

Travel must begin/end with the same major US airport, with the same service. Stopovers, open jaws, circle trips or frequent traveler mileages are not permitted. Once passengers are ticketed,

an airline change fee must be paid by the winner to change flights or dates of travel. Winners will be responsible for ground transportation to/from the airport at point of origin.

One (1) full size rental car will be provided for five (5) days in Orlando. Rental car must have a driver who is at least twenty-five (25) years of age or older, have a valid driver's license and credit card (subject to terms and conditions of rental car company) and will be responsible for any additional costs associated (including supplemental insurance, gas, taxes, etc).

Accommodations will be provided by Lake Buena Vista Resort Village & Spa for one (1) two bedroom/two bath suite for five (5) days and four (4) nights based on availability at time of booking. Accommodations do not include meals, incidentals, tips, telephone calls or any other personal expenses incurred during the trip.

Winner will receive a \$100.00 spa credit from Lake Buena Vista Resort Village & Spa.

Winner will receive four (4) single-day single-park admission tickets to winner's choice of Walt Disney World®, SeaWorld® Orlando or Universal Orlando® (one single-day single park admission ticket per person).

Winner and up to three guests will receive one (1) behind-the-scenes tour experience at winner's choice of one of the following theme parks- Walt Disney World®, SeaWorld® Orlando, or Universal Orlando®. If the tour requires park admission, winner and guests may use the admission tickets provided as part of this prize.

Winner will also receive a \$250.00 Shopping Spree at Orlando Premium Outlets.

Entire trip must be completed by December 1, 2010. Standard blackout dates or other restrictions may apply as dictated by airline and/or hotel. All reservations are based on availability and must be booked at least 30 days in advance of travel date. No trips may be taken during the blackout periods specified by the aforementioned prize package partners.

Approximate Retail Value of Prize: \$4,390.00. Actual value may vary based on location and timing of departure.

All other expenses are the winner's responsibility, including local and ground transportation, telephone, meals, room-service charges, and gratuities. Any penalties associated with changes made to any reservation following confirmation of booking will be the responsibility of winner. prospective grand prize winner will be deemed ineligible, and an alternative prospective grand prize winner will be selected at random from the remaining runner up prize winners.
